I am writing to advise members of the College that our AGM will be held virtually on Tuesday 22 February 2022.

Apart from the formal business below, we hope to have some time for "creativity", opportunities to share some conversations with members and actively listen to current concerns. Members wishing to submit formal items for the business on the agenda are asked to respond to me in writing no later than Friday 21 January 2022 at 12:00 hr. Papers with the full agenda, minutes of the last meetings and associated papers will be issued shortly after this.

Elections for the following positions will also be held:
